- (a) whether the National Commission for Scheduled Tribes (NCSTs) has received any complaints regarding job, land, atrocity, education from various States during the last three years;
- (b) if so, the details thereof and the action taken by the NCST/Government thereon, State/UT-wise including Odisha; and
- (c) the steps taken/being taken by the NCST/Government for timely disposal of such complaints?
