#### WELFARE SCHEMES FOR TRIBAL AND BACKWARD AREAS

#### 1233. SHRI NISHIKANT DUBEY:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether any specific schemes aimed at development of Tribal and backward areas of the country are being implemented by Government;
- (b) if so, the details thereof along with the implementation status of the said schemes State/UT-wise including Jharkhand;
- (c) whether the Government has received proposals from various State Governments seeking higher allocations for development of tribal and backward areas in their States; and
- (d) if so, the details thereof along with the action taken by the Government thereon, State/UT-wise?

#### **ANSWER**

# MINISTER OF STATE IN THE MINISTRY OF TRIBAL AFFAIRS (SHRI JASWANTSINH BHABHOR)

(a)&(b): Yes, Madam. Ministry of Tribal Affairs implements two Special Area Programmes i.e. Special Central Assistance to Tribal Sub-Scheme (SCA to TSS) and Grants under Article 275(1) for the development of tribal and backward areas. These are flexible programmes wherein funds are provided to States for interventions in various sectors like health, education, minor infrastructure, livelihood, skill development etc. These supplement the initiatives of various schemes / programmes of concerned Central Ministries and the State Governments.

Apart from these two programmes which are specifically for the welfare of STs, 32 Central Ministries/ Departments are mandated for provisioning a certain percentage of their total budget towards Scheduled Tribe Component (STC) (hitherto known as Tribal Sub Plan). In 2017-18 an amounting of Rs. 30962.47 crore is allocated as Scheduled Tribe Component under 273 schemes.

Ministry of Tribal Affairs also implements following schemes for welfare of tribal / backward areas:

(i) Ashram Schools: Funds are provided to States for making residential schools for STs for primary, middle, secondary and senior secondary level of education.

- (ii) ST Hostels: Central assistance is given to States/UTs for construction of new hostel buildings and/ or extension of existing hostels.
- (iii) Scheme of Vocational Training in Tribal Areas (VTC): The main aim of the Scheme is to develop the skills of the ST youth for a variety of jobs as well as self-employment and to improve their socio-economic condition by enhancing their income.

Assistance provided to various State Governments including Jharkhand under the specific programmes for welfare of STs(SCA to TSS and Grants under Article 275(1) during the last three years and current year is at **Annexure – I** and assistance provided under the schemes of Ashram schools, Hostels and VTC is at **Annexure – II.** 

(c)&(d): Every year State Governments send proposals to the Ministry for funding under Special Central Assistance(SCA) to Tribal Sub-Scheme (TSS) and Article 275(1) of the Constitution. Every year, each State is allocated a specific amount from the budget. Though proposals for higher allocations are received from some States, the proposals are approved within the amount allocated to each State. Only in case of balance funds availability, in view of their not being released to certain States, due to reasons like non-receipt of Utilisation Certificates, or non-receipt of proposals/disapproval of proposals, such amounts are then sanctioned to other States above the initial amount allocated to them.

Some of the Schemes are demand driven and funds are allocated keeping in view the requirement of the State Governments/UT Administrations/Organizations/Bodies seeking funds, and the availability of funds.

Besides, under the scheme of Development of Particularly Vulnerable Tribal Groups(PVTGs), proposals from the State Governments have been received for amounts higher than the budget allocation for each State, however, grants are sanctioned as per the funds availability.
