Will the Minister of Skill Development and Entrepreneurship be pleased to state:

(a) whether the Government is making efforts to establish small Industrial Training Institutes (ITIs) and promote technical education in various parts of the country especially 'Pahari Korba' scheduled tribe dominated areas of the country including the State of Chhattisgarh;

(b) if so, the details thereof and the State-wise details of the ITIs established in the country as on date;

(c) the expenditure made to establish ITIs in the country during the last three years and the current year; and

(d) the State-wise and fund-wise details made under various heads for ITIs in the country including the State of Chhattisgarh during the said period?

ANSWER

MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

(a) to (d) Setting up of ITIs (by own funds) and day to day administration including admissions in ITIs is under the domain of respective States/UTs. However, Directorate General of Training, Ministry of Skill Development & Entrepreneurship has formulated following schemes to assist State Governments for establishment of ITIs:

- Skill Development in 47 Districts Affected by Left Wing Extremism The scheme envisages establishment of 47 new Industrial Training Institutes (ITIs) in 47 districts affected by Left Wing Extremism in 10 States. This includes Sitapur block of Surguja district in Chhattisgarh having population of schedule tribe "Pahari Korba. An amount of Rs. 171.18 crore (includes75% Central and 25% State share) has been released for the purpose so far. The State-wise details of districts covered, allocation and fund released are at Annexure-I.
- Enhancing Skill Development Infrastructure in NE States & Sikkim The scheme envisages establishment of 22 new ITIs in 8 Northeastern States. An amount of Rs.102.90 crore (includes 90% Central and 10% State share) has been released for the purpose. The State-wise details of allocation and fund released are at Annexure–II.
