# Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) the details regarding role of State Governments and sector skill councils of NSDC in determining the training programmes of the Pradhan Mantri Kaushal Kendras (PMKKs);

(b) the number of women, scheduled castes, scheduled tribes, minorities and people with disabilities certified under the yojana so far;

(c) the number of people certified so far who have also received placements, State-wise; and

(d) the steps taken for speedy setting up of the PMKKs in the remaining places, which have been identified in the country?

# ANSWER

# MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

(a) to (d) Ministry of Skill Development and Entrepreneurship through National Skill Development and Corporation is implementing Pradhan Mantri Kaushal Kendra (PMKK) for establishment of model aspirational skill centres in every district for imparting skill training through Pradhan Mantri Kaushal Vikas Yojana (PMKVY). State Government has no such role in the establishment/conducting of training programme in PMKKs. Under the skill ecosystem, the concerned Sector Skill Council (SSC) develop sector specific Qualification Packs/National Occupational Standards (QPs/NOS) for various job roles. Some highly demand courses/job roles developed by concerned SSCs are kept under PMKVY for imparting skill development training. As on 16<sup>th</sup> July 2017, 556 PMKKs have been allocated to 514 districts throughout the country. Further, as on 13<sup>th</sup> July 2017, a target of 3,49,904 has been allocated to 171 PMKKs.

Under PMKK, State-wise number of people certified and also received placements is given at **Annexure -I**. Also, the number of certified women, scheduled castes (SC), scheduled tribes (ST), other backward class (OBC) and people with disabilities (PwDs) are given below:
