FUNDS ALLOCATED UNDER PMAY

No. 1754 PROF. PREM SINGH CHANDUMAJRA

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- a) whether 90,000 crore rupees have been allocated for the construction of low cost houses under the Pradhan Mantri Awas Yojana (PMAY) and if so, the details thereof;
- b) the details of the amount released as on March 2017 from the said allocation; and
- c) the State-wise details of the amount allocated for this purpose?

(a) : For construction of low cost houses under the Pradhan Mantri Awas Yojana (Urban)-Housing for All {PMAY(U)-HFA} Mission, budgetary allocations of Rs. 4000.00 crore and Rs. 4400.00 crore were made during FY 2015-16 and FY 2016-17 respectively. These allocations were further reduced to Rs. 1231.23 crore and Rs. 4342.43 crore at RE 2015-16 and RE 2016-17 stages respectively, taking into consideration the pace of implementation of the Mission. During the current FY 2017-18, Rs. 4550.90 crore has been allocated for PMAY (U). Further, under Credit Linked Subsidy Scheme (CLSS) component of PMAY (U), budgetary allocations of Rs. 200.00 crore, Rs. 475.00 crore and Rs. 400.00 crore were made during FY 2015-16, FY 2016-17 and FY 2017-18 respectively.

(b) & (c): As on 31st March, 2017, under the PMAY (U), central assistance of Rs. 6101.00 crore was released, the State/UTs wise details of which are annexed.
