SHELTER FOR ELIGIBLE BENEFICIARIES AS PER SECC

2020. SHRI CHANDU LAL SAHU:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether as per Socio-Economic and Caste Census (SECC-2011) data as large as 4 crore eligible beneficiaries require shelter in the country and if so, the details thereof along with the details of eligible beneficiaries across the country, State/UTwise;
- (b) whether the Government has initiated an all-out effort to eradicate shelterlessness from the country in a phased and time-bound manner;
- (c) if so, the details thereof and the progress made till now in this direction; and
- (d) the number of beneficiaries who have been given shelter during the last three years, State/UT-wise?

ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a) : A statement indicating State/UT-wise number of households eligible for getting PMAY-G assistance, as per Socio Economic and Caste Census (SECC), 2011 and number of households as verified by the Gram Sabha and reported by the States/UTs on AwaasSoft is at Annexure-I.

(b) and (c) : To achieve the objective of 'Housing for All by 2022' the rural housing scheme Indira Awaas Yojana (IAY) has been re-structured into Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) which aims to provide pucca house with basic amenities to all houseless households and households living in houses with kutcha wall and kutcha roof having zero, one or two rooms as per Socio Economic and Caste Census (SECC), 2011 in rural areas of the country. In initial phase one crore houses are proposed to be constructed over a period of three years from 2016-17 to 2018-19 and as on 24.07.2017 84,233 houses have been completed as reported by the States on AwaasSoft.

(d) : A statement indicating number of house constructed under PMAY-G (erstwhile IAY) during last three years is given at Annexure-II.
