2121. SHRI GANESH SINGH:

Will the Minister of **AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH)** be pleased to state:

- (a) whether the Government has sanctioned any annual grants for the development of AYUSH centres under the National AYUSH Mission in the Madhya Pradesh;
- (b) if so, the total amount proposed and sanctioned in Madhya Pradesh under the National AYUSH Mission;
- (c) whether the Government has taken any steps to sanction 46.3 crores for State Annual Action Plan (SAAP) under the National AYUSH Mission for the year 2017-18 in Madhya Pradesh; and
- (d) if so, the details thereof?

ANSWER

(a) & (b): Under Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is provision of financial assistance for the States/UTs including Madhya Pradesh to open AYUSH Wellness Centres including Yoga. Government of India has received proposals to open AYUSH Wellness Centres including Yoga from different States/UTs including Madhya Pradesh through State Annual Action Plan (SAAP). State Government of Madhya Pradesh has proposed Rs. 186.00 Lakhs for 31 AYUSH Wellness Centres including Yoga during the year 2015-16 & Rs. 167.40 Lakhs for 31 AYUSH Wellness Centres including Yoga during the year 2016-17 under NAM and same has been sanctioned to Madhya Pradesh.

(c) & (d): Under National AYUSH Mission (NAM) State Government of Madhya Pradesh has submitted State Annual Action Plan (SAAP) of Rs.46.03 crores for the year 2017-18. Accordingly, Ministry of AYUSH has approved the SAAP for an amount of Rs. 34.90 crores in accordance with the NAM guidelines as per the details furnished at **Annexure**.
