AYURVEDA COLLEGES

2213. SHRI RAOSAHEB DANVE PATIL:

Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) the details of the recognised ayurvedic colleges in the country, State/UT-wise;
- (b) whether the Government proposes to open/grant recognition to new ayurvedic colleges particularly in backward and tribal areas in the country and if so, the details thereof, State/UT-wise;
- (c) whether the Government has received any proposals in this regard, if so, the details thereof; and
- (d) the action taken by the Government thereon during the last three years and the current year, State/UT-wise?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

- (a): The details of ayurvedic colleges in the country State/UT wise are given at **Annexure-I**.
- (b): Presently, there is no proposal with the Central Government for opening of new ayurvedic college in the country. However, last year the North East Institute of Ayurveda & Homoeopathy (NEIAH) at Shillong opened.
- (c): Yes, the Government has received 65 proposals for starting new Ayurveda colleges, this year. The State/UT-wise details are given at **Annexure-II**.
- (d): The Government received 39 proposals during the year 2014; 65 proposals during the year 2015 and 108 proposals during the year 2016 to open new Ayurveda colleges. Out of these, 16 colleges in 2014 and 44 colleges in 2015 were permitted by the Government. Out of the 108 proposals received during 2016, Letter of Intent (LOI) has been issued to 64 colleges and 02 are under process for grant of LOI. The State/UT-wise details are given at **Annexure-III.**
