2281. SHRI BISHNU PADA RAY:

Will the Minister of **AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH)** be pleased to state:

- (a) whether the Ministry has received any representations from public representative of Andaman regarding nonsubmission of project proposals by UT Administration with regard to opening of AYUSH hospitals under the Centrally Sponsored Scheme of National AYUSH Mission in all three districts viz. at Rangat and Diglipur of N&M Andaman District, Little Andaman Island, Car Nicobar, Kamorta and Campbell Bay of Nicobar District and additional one in rural areas of South Andaman District;
- (b) if so, the details thereof and the response of the Government thereon;
- (c) whether UT Administration has submitted any proposal for implementing AYUSH schemes in A&N Islands; and
- (d) if so, the details thereof and Government response thereon?

(a) & (b): Ministry has received a representation with regard to opening of AYUSH hospitals under the Centrally Sponsored Scheme of National AYUSH Mission in all three districts viz. at Rangat and Diglipur of N&M Andaman District, Little Andaman Island, Car Nicobar, Kamorta and Campbell Bay of Nicobar District and additional one in rural areas of South Andaman District. In this regard, Ministry has replied the public representative that the Union Territory Government is required to submit the proposal through State Annual Action Plan (SAAP) as per NAM guidelines.

(c) & (d): Yes, under Centrally Sponsored Scheme of National AYUSH Mission (NAM), the UT Administration has submitted State Annual Action Plan (SAAP) during 2014-15, 2015-16, 2016-17 and 2017-18 as per NAM guidelines which *inter-alia* include the components of AYUSH Services, Quality Control of Ayurveda, Siddha, Unani & Homoeopathy (ASU & H) Drugs, Flexipool components and Administrative cost.
