2493. SHRI NAGENDRA KUMAR PRADHAN:

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether the Ministry is providing Central share funds for the centrally funded scheme in Rashtriya Uchchatar Shiksha Abhiyan (RUSA);
- (b) if so, the details thereof and the Central share of funds approved and released by the Ministry for the State of Odisha so far and the total amount still pending in different heads; and
- (c) the time by which the pending Central share is likely to be released?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (DR. MAHENDRA NATH PANDEY)

(a) to (c): Under the Centrally Sponsored Scheme of Rashtriya Uchchatar Shiksha Abhiyan (RUSA), the Central Government provides funds in the ratio 60:40 to the States, 90:10 to North-Eastern Region (NER), Himachal Pradesh, Jammu & Kashmir and Uttarakhand and 100% to Union Territories.

The Central Share is provided in instalments to the States/UTs. The first instalment is released after compliance of conditions, if any, as approved by the Project Approval Board (PAB) of RUSA. The subsequent releases to States/UTs are subject to submission of Utilisation Certificate of more than 75% utilisation of the previous instalment. Further, the final instalment is released only after the concerned State/UT submits the Utilisation Certificate for the previous instalments released together with physical inspection report of institutions funded under RUSA.
