CASES REGISTERED UNDER SEDITION ACT

2531. DR. SHASHI THAROOR:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) the number of cases registered under the Sedition Act against individuals who have supported cricket teams post match;**
- (b) the action taken against the individuals;**
- (c) the manner in which the Government determined that the support of sports team, constitutes anti-national sentiments or seditious acts;**
- (d) the manner in which such individuals were arrested, given that they did not act in a violent manner as reported in the media; and**
- (e) the time taken in the investigation process before such arrests were made?**

(a) to (e) The National Crime Records Bureau (NCRB) has intimated that the information on cases registered under the Sedition (Section 124 A of IPC) against individuals who have supported cricket teams post match is not specifically maintained by them.
