RECRUITMENT OF CISF PERSONNEL

2580. SHRI P. NAGARAJAN:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether the Government has decided to recruit 35,000 personnel for inducting them in Central Industrial Security Forces (CISF) during the year 2017;
- (b) if so, the details thereof;
- (c) whether the proposed recruitment will be conducted across the country;
- (d) if so, the total number of personnel likely to be recruited from Tamil Nadu; and
- (e) the time by which the recruitment process is likely to be completed?

 ANSWER

MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI KIREN RIJIJU)

- (a) & (b) : The ceiling of the strength of Central Industrial Security Force (CISF) has been raised from 1,45,000 to 1,80,000 posts. The details of recruitment under process and future recruitment for filling up of vacant posts in various ranks are at Annexure 'A'.
- (c) to (e): Recruitment for the post of Sub-Inspector/Executive, Assistant Sub-Inspector/ Executive, Assistant Sub-Inspector/Steno and Head Constable/Ministerial is conducted on all India basis. Regarding recruitment of Constable, State-wise vacancies are allocated proportionately to the concerned States on population basis.

L.S.US.Q.NO.2580 FOR 01.08.2017

183 posts of Constable (General Duty) out of 5380 posts have been projected for the state of Tamil Nadu on state population basis.

Recruitment is an ongoing process. Vacancies are notified time to time every year to fill up the vacant posts. All recruitment are completed within the time frame.
