Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

- (a) whether the Government has any data regarding the hiring of private warehouses to keep the foodgrains and if so, the details thereof;
- (b) whether any policy has been formulated to hire godowns on rent by Food Corporation of India (FCI) and if so, the details thereof, State-wise including Chhattisgarh;
- (c) the number and the details of the godowns hired on rent during each of the last three years and the current year;
- (d) whether FCI has refused to rent certain godowns which have been constructed as per the designs and specifications given by FCI itself; and
- (e) if so, the details thereof including the number of such godowns and the reasons therefor, State-wise?

(a): Yes, Madam. The details of the private warehouses hired by Food Corporation of India (FCI) during the last three years (as on 31st March) and current year as on 30.06.2017 are as given below:-

(b) & (c): Yes Madam. FCI hires godowns from Central Warehousing Corporation (CWC), State Government Agencies and private parties for storage of foodgrains. Hiring of godowns from CWC & State Government Agencies is the preferred route of hiring by FCI. The rate of rent payable by FCI to CWC/State Government Agencies is fixed by the Government. Wherever sufficient capacity is not available with FCI or State Agencies, private godowns are hired through the process of competitive bidding. Under PEG Scheme, godown is constructed by the private party selected through tendering process and FCI hires the godown on guaranteed basis for 10 years.

The details indicating number of godowns hired on rent along with capacity during the last three years and the current year are given as below:-
