- (a) Since the inception of Deendayal Antyodaya Yojana National Urban Livelihoods Mission (DAY-NULM) in 2014-15, 8,37,764 beneficiaries have been skill trained of which 2,48,680 candidates were given placement; 1,78,361 beneficiaries have been assisted with subsidised loan to set up individual/group microenterprises, 1,62,185 Self Help Groups (SHGs) have been formed, 1,02,080 SHGs have been given Revolving Fund and 2,67,478 loans have been given to SHGs under SHG Bank Linkage Programme, during the period from April 2014 to March 2017.
- (b) State/ UT-wise achievement in terms of employment generated under DAY-NULM is at Annexure I.
