2837. SHRI RABINDRA KUMAR JENA:

Will the Minister of STATISTICS AND PROGRAMME IMPLEMENTATION be pleased to state:

- (a) the annual Gross State Domestic Product (GSDP) data at constant and current prices along with per capita levels thereof during each of the last three years, State/UT-wise;
- (b) the Gross Domestic Product, Net Domestic Product, National Income and GDP growth rate of the country during the said period;
- (c) the sector-wise contribution to GDP of the country during the said period;
- (d) the corporate and non-corporate sector GDP contribution during the said period; and
- (e) whether the Government is maintaining and publishing easily downloadable data series on important indicators such as GSDP and if so, the details thereof and if not, the reasons thereof?

ANSWER

MINISTER OF STATISTICS AND PROGRAMME IMPLEMENTATION (SHRI D. V. SADANANDA GOWDA)

- (a): Annual estimates of Gross State Domestic Product (GSDP) and Per Capita Income (measured as per capita net state domestic product) at constant and current prices are prepared by all the States/UTs except UTs of Daman & Diu, Dadra & Nagar Haveli and Lakshadweep. As per latest reports, data for the 33 States/UTs is available till the year 2014-15. The information is given in the statement at Annexure.
- (b): Estimates of Gross Domestic Product (GDP), Net Domestic Product (NDP) and National Income, measured as Net National Income

(NNI) at current prices and GDP growth rate at constant prices (at base year 2011-12) during last three years are as under:
