Will the Minister of ROAD TRANSPORT AND HIGHWAYS सड़क परिवहन और राजमार्गमंत्री

be pleased to state:

(a) the details of funds allocated for construction of National Highways (NHs) during each of the last three years and the current year, State-wise including Jharkhand;

(b) whether the funds have been released, so far, for highways in Jharkhand out of the sanctioned amount and if so, the details thereof, year-wise; and

(c) if not, the reasons therefor and the details of reasons for delay in disbursement of funds?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF ROAD TRANSPORT AND HIGHWAYS (SHRI PON. RADHAKRISHNAN)

(a) to (c) The development and maintenance of National Highways (NHs) are carried out through various agencies, such as the State Governments (State Public Works Departments (PWDs), Road Construction Departments (RCDs), etc.), National Highways Authority of India (NHAI), National Highways and Infrastructure Development Corporation Limited (NHIDCL), Border Roads Organization (BRO), etc.

State/Union Territory (UT)-wise allocation of funds for development of NHs are made based on existing liabilities against sanctioned works and availability of resources. State/ UT–wise details of allocation of funds and expenditure for development of NHs during the last three years and current year, including for the State of Jharkhand, are **annexed**.

There has been no delay in allocation of funds.
