3252. SHRI PR. SENTHIL NATHAN:

Will the Minister of CORPORATE AFFAIRS be pleased to state:
(a) whether the Government has taken any strict action against the fraudulent companies through the Serious Fraud Investigation Organisation (SFIO) and restored the money back to the victims of fraudulent finance/chit companies; and
(b) if so, the details thereof for the last five years, State/year-wise?

(a) to (b): In the cases of complaints of serious nature involving companies which have defaulted after raising money from the public, the Ministry ordered investigation by the Serious Fraud Investigation Office (SFIO) under Section 210 and 212 of the Companies Act, 2013. The details are as per Annexure-I. No money in these cases has been restored back to the investors.
