RECOMMENDATION OF NCSC

3457. PROF. PREM SINGH CHANDUMAJRA:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the National Commission for Scheduled Castes (NCSC) has recommended to the Department of Telecommunications (DoT) and Mahanagar Telephone Nigam Limited (MTNL) to revise the seniority of Scheduled Caste Officers as per Department of Personnel and Training (DoPT) guidelines issued pursuant to 85th Constitution Amendment Act, 2001 and sought action taken report in this matter;
- (b) if so, the details thereof;
- (c) whether DoT/MTNL have submitted action taken report to NCSC;
- (d) if so, whether NCSC is satisfied with the report and revised seniority of the affected Scheduled Caste Officers; and
- (e) if not, the steps taken by the Government to safeguard the interests of Scheduled Caste Officials?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI VIJAY SAMPLA)

- (a): Yes, sir.
- (b): The National Commission for Scheduled Castes (NCSC) had received representations from some Scheduled Caste officers working in the Mahanagar Telephone Nigam Limited (MTNL) under the Department of Telecommunication (DoT) regarding wrong fixation of seniority and non implementation of 85th Constitution Amendment Act, 2001. The Commission heard both MTNL and the Department of Telecommunication in the matter. NCSC in its final hearing dated 12.10.2015 issued certain recommendations (copy placed at Annexure-I).
- (c): Yes, sir (Copy placed at Annexure-II).
- (d): The NCSC has acted as per its mandate under Article 338 of the Constitution of India and issued its recommendations to MTNL/DOT.
- (e): Does not arise.

NATIONAL COMMISSION FOR SCHEDULED CASTES

Proceedings of the hearing held on 12-10-2015 in the Commission to discuss the representation of Shri Achachey Lal & others, SDE, MTNL New Delhi regarding fixation of seniority and denial of promotion in TES Group as per the 85th Amendment Act of the Constitution.

The matter is taken for hearing on 12-10-2015. Shri N.K. Yadav, Member (S), DOT, Shri Rajbir Singh, DDG (Estt.), and other Senior Officers from DoT are present. The officers from the MTNL was also present. The petitioners Shri Ram Singh & Shri Ganga Sharan are also present.

The petitioner Shri Ram Singh has intimated to the Commission that he was recruited to the post of JTO in the year 1980 and promoted to the post of SDE in 1993. His seniority is 13344.394 in the seniority list of the SDE whereas Shri Inderiit Tiwari (General category) whose recruitment year as JTO is 1976 and promoted to the post of SDE on 11-10-1998, his seniority has been fixed at serial no. 12915.000 above to him. The officers from the DoT stated that the Hon'ble Supreme Court has given a judgement in the case of Shri P.N. Lal & others on 26-04-2000 in CA No. 4339/ 1995 lays down seniority on the basis of recruitment year and 85th Constitutional Amendment Act, 2001 which provides "restoration of seniority of SC/ST Government servants on promotion by virtue of rules of reservation vide DoPT O.M. dated 21.1.2002. The extract of DoPT order dated 21.2.2002 provides that" The Government have now decided to negate the effects of the DoPT OM dated 30.1.1997 by amending Article 16(4A) of the Constitution right from the date of its inclusion in the Constitution i.e 17.6.1995 with a view to allow the Government servants belonging to SCs/STs to retain the seniority in the case of promotion by virtue of rule of reservation. In other words, the candidate belonging to General/ OBC category promoted later will be placed junior to the SC/ST Government servants promoted earlier even though by virtue of the rule of reservation. The SC/ST Government services shall, on their promotion by virtue of reservation/ roster be entitled to consequential seniority and further promotions."

The petitioners stated that the report of the Department of Telecommunication dated 20-6-2014 to the Commission that the seniority list is as per 85th Amendment Act and in compliance with Hon'ble Supreme Court judgement is not correct as Hon'ble Supreme Court in its judgement dated 26-4-2000 stated that "all the eligible candidates who had passed the departmental examination and who had been recruited in 1950, are to be listed separately from those officers who also have qualified departmental examination and were recruited in the year 1951 and so on and so forth. Once, separate lists are prepared by the Departmental Promotion Committee of the officers recruited in different recruitment years in the feeder category and the criteria for promotion being seniority-cum-fitness, and then it would create no problem in promoting the officers concerned."

Hence in view of the above the department of telecommunication is advised to re-examine the matter in the light of the petitioner's contention and the DoPT OM No. 20011/1/2001-Estt. (D) dated 21-1-2002. The said DoPT guidelines will also be applicable to all other SC officers working in MTNL whose seniority was affected. Submit an Action Taken Report to the Commission within a period of 30 days positively.

Sir,

I am directed to refer to letter under reference on the above mentioned subject and to state that Shri Achchhey Lal has already been absorbed in MTNL w.e.f. 01.10.2000 on permanent basis and he is no longer Govt. employee. The Personnel & Establishment matters such as promotion, seniority etc., of Shri Achchhey Lal are under the purview of MTNL only and DoT has no role to play in such matters.

- 2. The records, in original, relating to promotion, seniority, court cases, DPC etc., which were being dealt with by DoT prior to absorption of TES Group 'B' officers in MTNL/BSNL, have already been transferred to MTNL/BSNL for taking appropriate action at their end since there is no employee-employer relationship between the absorbed TES Group 'B' officers of MTNL/BSNL and DoT.
- 3. MTNL has also circulated the seniority list of their absorbed TES Group 'B' officers as intimated by MTNL by their letter dated 05.03.2009.
- 4. If, Shri_sAchchhey Lal is having any grievance regarding assignment of his seniority position, he should approach MTNL for re-dressal.
- 5. Shri Achchhey Lal has been knocking the doors of Commission at a regular intervals for such a relief which has already been granted to him by accelerating his seniority in the grade of TES Group 'B' Cadre from 17398 to 17198.056 as per Constitution (85th) Amendment Act-2001. However, the officer is claiming the seniority at 14146.070 which

was inadvertently assigned to him and later the same was withdrawn correctly, hence, the officer cannot claim for such seniority inadvertently granted and for which he is actually not entitled. The seniority claimed by Shri Achchhey Lal has not been accepted/considered by DoT.

6. It is therefore, requested that the action may be taken by MTNL at their end and a reply may be given to Shri Achchhey Lal accordingly
