Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the Government considers to allocate greater amount of funds under the Submission on Agriculture Mechanisation (SMAS) scheme to meet the farmers mechanisation demand of States, particularly the State of Odisha and if so, the details thereof and the steps being taken in this regard;
- (b) whether the Government has taken steps to include straw baler thereunder and if not, the reasons therefor; and
- (c) whether the Government proposes to enhance the calamity Relief fund Grant suitably from the existing Rs. 6800/- and Rs. 13500/- per hectare for unirrigated and irrigated lands respectively and if so, the details thereof?

ANSWER

(a): To promote the farm mechanization in the country, Government of India has introduced Sub Mission on Agricultural Mechanization (SMAM) w.e.f. 2014-15. To implement the SMAM scheme, Government has enhanced the funds from Rs.208.3 Crore to Rs.577.58 Crore during 2014-15 to 2017-18 respectively.

As regards to Odisha State is concerned Government has released Rs.72.09 Crore under SMAM scheme during the period 2014-15 to 2017-18.

The statement of funds released under SMAM scheme to various States including Odisha State is enclosed as **Annexure I**.

- (b): Under SMAM scheme Straw Baler is already included and the financial assistance is provided for its procurement to the farmers.
- (c): Existing norms of assistance from State Disaster Response Funds (SDRF) and National Disaster Response Fund (NDRF) were revised on 8th April 2015 and these norms are applicable up to the year 2019-20 There is no any proposal of Government to enhance the existing norms of assistance of SDRF and NDRF.
