- (c) the monitoring mechanism for the said welfare schemes;
- (d) the details of the grant-in-aid sanctioned under the said schemes during the last three years and the current year, scheme-wise; and
- (e) the time by which the pending proposals are likely to be sanctioned?

- (a) & (b): The details of proposals received from the State Government of Chhattisgarh during the last three years and current year (upto 30-06-2017) including the number of proposals sanctioned and pending under various welfare schemes is **Annexure-I**.
- (c): Monitoring of the schemes done both at State and Central level. Further, regularly Annual Progress Reports and Utilization Certificates are obtained from the State Governments/UTs for the previous years. Independent agencies also conduct evaluation of the schemes from time to time.
- (d): The details of Grants-in-Aid sanctioned to the State Government of Chhattisgarh under various schemes during the last three years and the current year (upto 30-06-2017) are given at Annexure-II.
- (e): Proposals complete in all respects are sanctioned in the year of receipt itself. Pending proposals are sanctioned on removal of deficiencies as per guidelines of the respective scheme
