(a) whether the compensations announced by the Government for Kins of Kargil martyrs have not been fulfilled even after the passage of number of years;

(b) if so, the details thereof and the reasons therefor;

(c) the extent to which the announcements made for the kins of Kargil martyrs have been fulfilled till date; and

(d) the other steps being taken for the welfare of the kins of the martyrs?

(a) to (c): All the compensations announced by the Government for the Next of Kin (NoK) / families of defence personnel who died during Kargil War have been granted / released. The details are at Annexure-I.

(d) The details of Welfare Schemes / other facilities provided to the Next of Kin / families of defence personnel killed in action including the Kargil war are at Annexure-II.

Details of the Compensations to the Next of Kin of the Defence Personnel who died during Kargil War:

<u>Army</u>:

- (i) Number of Next of Kins of the Defence Personnel who died during Kargil War, who were compensated: 523
- (ii) Number of Kargil Battle Casualties (Non-Fatal)/Disabled: 174

(III) Entitled compensations given to NoK/families of the Defence Personnel who died during Kargil War are as follows:

- (a) Liberalized Family Pension
- (b) Death-cum-Retirement gratuity.
- (c) Disability/war injury pension.
- (d) Education Concession Card.
- (e) Air Travel Concession Card.
- (f) Ex-gratia compensation.

(iv) Compensation given to NoK/families from National Defence Fund (NDF) are as follows:

- (a) Grant for Dwelling Units.

- (c) Grant of Rs. 1000/- per month to dependent parents.

Air Force:

- (i) Three officers and two airmen died during Kargil War.
- (ii) Entitled compensation given to Next of Kins of the Defence Personnel who died during Kargil War are as follows:
 - (a) Liberalized Family Pension.
 - (b) Death-cum-Retirement gratuity.
 - (c) Ex-gratia compensation.
- (III) Grant made out of National Defence Fund (NDF):
 - (a) Grant of Rs. 5 lac to each of the Next of Kins for Dwelling Units.

- (b) Grant of Children Education: A monthly grant of Rs. 1000/- per child to be given for school going children till they attain 18/21 years of age. Thereafter, the principal amount of Rs. 1 lac paid to each child. In case of girls 18 years and, 21 years in the case of boys.
- (c) Grant of Rs. 1000/-pm to the dependents parents for 10 year.

<u>Navy</u>:

- (i) There were only two casualties in the Navy during Kargil War.
- (ii) Entitled compensation given to the Next of Kins of Defence Personnel who died during Kargil War are as follows:
 - (a) Liberalized Family Pension.
 - (b) Death-cum-Retirement Gratuity.
 - (c) Ex-Gratia compensation.
 - (d) Gallantry Award.

(iii) A sum of Rupees one Lakh was paid to each Next of Kins from the National Defence Fund.
