#### MISAPPROPRIATION OF FUNDS UNDER PMKVY

#### 522. SHRI PR. SENTHIL NATHAN:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) whether the Government has blacklisted any training partners for doing fraudulent enrolments and misappropriation of funds under the PMKVY;
- (b) if so, the details thereof and the list of such black-listed training partners, State-wise; and
- (c) the steps taken by the Government to impart skill training to more youths/women in the country and to employ them with decent salaries?

#### **ANSWER**

# MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJIV PRATAP RUDY)

- (a) & (b) Under Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2015-16, action on complaints against Training Centers and Monitoring of Training Centers is performed as per Monitoring Framework of PMKVY 2015-16. Complaints received under PMKVY 2015-16 are mostly related to fake enrolment and irregularities in conduct of training, improper trainings and lack of infrastructure in the centre, franchisor franchisee dispute and mass enrolment. The list of Training Partners/Centres suspended during PMKVY 2015-16 is at **Annexure-I**.
- (c) Ministry is implementing PMKVY 2016-20 with an objective to provide skilling or up-skilling to one crore youth including women (60 lakh under Fresh Training and 40 lakh under RPL) with an outlay of Rs.12,000 crore over four years (2016-2020).

Under the PMKVY 2016-20 scheme, the focus on employment has been significantly enhanced. Scheme incentivizes Training Centers (TCs)/ Training Partners (TPs) for facilitating placement of the trained candidates. TCs are mandated to organize placement/rozgar melas every six month with the support of Sector Skill Council. Various IT interventions such as Direct Benefit Transfer, Aadhaar linkage of trainers and trainees, Biometric attendance of candidate, SMART portal based Accreditation & Affiliation of TCs etc have been ensured. Additionally, there is a special provision in the scheme to provide post placement support to women, PwDs and candidates from special areas (LWE, North East region and J&K).
