(c) the details of Monitoring Committee working in Madhya Pradesh in this regard; and

(d) the details and total number of complaints of corruption received so far along with details thereof, State-wise during each of the last three years and the current year?

(a) and (b) District Development Co-ordination and Monitoring Committee (DDCMC)-Disha have been constituted in the district to monitor the progress of the programmes of rural development including Swachh Bharat Mission (Gramin). The Chairperson of the Disha is a Member of Parliament (Lok Sabha). The District Collector is the Member Secretary of Disha. Meetings of the Disha are being held at least once in every Quarter.

(c) District Development Co-ordination and Monitoring Committee (DDCMC)- Disha have also been constituted in Madhya Pradesh.

(d) State-wise , details and total number of complaints of corruption received during each of the last three years and the current year is at Annexure-1.
