- (a) whether it has come to the notice of the Government that the flights operated from various airports in Kerala are earning good revenue in the respective sectors;
- (b) if so, the details thereof and the annual revenue earned by Air India from the above said sectors during the last three years from passenger, cargo and ground handling services; and
- (c) the revenue shared in between Air India and Air India Sats (AISATS) during the last three years for the above said flights from airports in Kerala?

(a) and (b): The details of Passenger and cargo revenue for sectors operated by Air India from Kerala State is attached as Annexure. However, no such data is maintained in respect of other private airlines.

The revenue from ground handling services earned by Air India Air Transport Services Limited, a wholly owned subsidiary of Air India Limited during the last three years is as under:

Ground Handling Revenue of Kerala State comprising of Calicut & Cochin (figures in Crores):

2014-15 - 78.59 Cr.

2015-16 - 81.47 Cr.

2016-17 - 72.31 Cr.

(c): Air India has joint venture (50:50) with Air India SATS. Therefore, revenue shared in between Air India and AISATS does not arise.
