- (a) the number of widow, deserted and destitute women in various States of the country including Chhattisgarh, State/UT- wise;
- (b) whether the Government has conducted or proposes to conduct any survey with regard to such destitute women who are living separately from their husbands despite not giving the divorce:
- (c) if so, the details and the outcome thereof; and
- (d) the steps taken by the Government for the welfare of such women?

- (a) A statement giving Census 2011 data on widowed, separated and divorced women as furnished by the Office of the Registrar General, India is enclosed as Annexure.

- (d) The Ministry of Women and Child Development is implementing the Swadhar Greh Scheme which targets the women victims of difficult circumstances who are in need of institutional support for rehabilitation so that they could lead their life with dignity.
