Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the number of petrol pumps/LPG Agencies/CNG pumps allocated to various categories of people including SCs/STs by the Oil Marketing Companies (OMCs) during the last three years, OMC/State/UT/ Category-wise separately;

(b) the number of allotted petrol pumps/ LPG agencies/CNG pumps where the Letter of Intent has not been issued to the people belonging to SCs/STs, OMC-wise and State/UT-wise; and

(c) the details of the facilities provided to the SC/ST beneficiaries?

STATEMENT REFERRED TO IN REPLY TO LOK SABHA STARRED QUESTION NO. 26 ASKED BY SHRI RATTAN LAL KATARIA FOR ANSWER ON 18.12.2017 REGARDING ALLOTMENT OF PETROL PUMPS/LPG AGENCIES/CNG PUMPS.

(a) : The State/UT/OMC-wise number of Retail Outlets and LPG Agencies allotted to various categories of people including SCs/STs by Oil Marketing Companies (OMCs) during the last three years are given in **Annexure-I & Annexure-II respectively.**

Compressed Natural Gas (CNG) is marketed by City Gas Distribution (CGD) companies either through existing retail outlets offered by OMCs or through standalone CNG stations set up by them.

Based on Expression of Interest (EOI) received and the potential Geographical Area (GA) identified by Petroleum and Natural Gas Regulatory Board (PNGRB), PNGRB invites bids, evaluates them and awards authorization to an entity for laying, building and operating of CGD network in such GA. As and when such CNG entity approaches OMCs for setting up of CNG facilities, retail outlets of OMCs are offered considering the availability of sufficient space at the outlet as per norms of Explosive department and potential CNG demand in the area.

Standalone CNG stations are set up by City Gas Distribution (CGD) companies who have their selection guidelines for setting up CNG stations.

(b) : The State/UT/OMC-wise number of allotted Retail Outlets and LPG Agencies pending for issue of the Letter of Intent (LOI) to the people belonging to SCs/STs are given in **Annexure-III & Annexure-IV respectively.**

(c) : The details of the facilities provided by the OMCs to SC/ST beneficiaries in respect of retail outlet dealerships and LPG distributorships are as under :

<u>Retail Outlets</u> –

<u>Selection Process</u> - Scheme of Financial Assistance to SC/ST Category Dealerships under "Corpus Fund Scheme" -

- (i) Financial assistance will be given to persons belonging to SC/ST on award of dealerships by the Oil company, which will make available the ready Retail Outlet with required facilities at its cost on the land offered by the candidate and procured by the Company on mutually agreed terms and conditions.
- (ii) Oil Company will also provide adequate working capital loan for a full operation cycle of the operation of the Dealerships. Both the working capital as well as 11% per annum interest thereon will be recovered in 100 equal monthly installments commencing from the 13th month of commissioning of the Dealership.

(iii) SC/ST candidates have been given relaxation to apply for retail outlet dealerships and offer land within a period of 9 months.

Commissioned SC/ST dealership-

- (i) Under Corpus Fund Scheme, for locations reserved under SC/ST category, the Oil Company will make available the ready retail outlet with all basic facilities at its cost on the land offered by the candidate and procured by the Company.
- (ii) For operating the retail outlet, Oil Company will extend Financial Assistance by way of loan towards working capital.

LPG Distributorships

- (i) The refundable security deposit for SC/ST distributors is less than the amount fixed for General / OBC distributors.
- (ii) Selected candidate for the location reserved under SC/ST category has the option to avail the following Financial Assistance Scheme :
 - (a) OMCs shall facilitate the selected candidate in obtaining the loan from scheduled commercial bank for constructing the LPG Godown, Showroom and LPG cylinder delivery infrastructure.
 - (b) The secured loan towards margin money will be provided to Distributorships reserved for SC/ST categories at (SBI PLR +1%) interest per annum. This loan as well as interest will be recovered at the rate of 20% of distributor`s commission.
 - (c) Adequate working capital loan at (SBI PLR +1%) interest per annum, for a full operation cycle of the operation of the distributorship will also be provided. Both the working capital as well as interest thereon will be recovered in 100 equal monthly installments from the 13th month of commissioning of the Distributorship.
