BUDGET ALLOCATION FOR SCHEDULED TRIBES

*38. SHRI P. KARUNAKARAN:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

- (a) whether the Government has made any budget allocation for the development / upliftment of the Scheduled Tribes in accordance with the percentage of population and if so, the details thereof; and
- (b) the details of the percentage of Scheduled Tribes population and the budget allocation for the last three years for their development/upliftment?

ANSWER

MINISTER FOR TRIBAL AFFAIRS (SHRI JUAL ORAM)

(a) to (b): A statement is laid on the Table of the House.

Statement referred to in reply to Lok Sabha Starred Question No.*38 for answer on 18.12.2017 asked by Shri P. Karunakaran:

(a) & (b): Earmarking of funds for STs was done by the concerned Ministries/Departments against their Plan allocation under the broad strategies of Tribal Sub-Plan (TSP) as per the criteria recommended by the Task Force, 2010. The Task Force constituted by the erstwhile Planning Commission had recommended for differential earmarking i.e. earmarking at different rates by the Ministries / Departments and only against their plan outlay as at **Annexure 1**. After merger of Plan and Non-Plan, Ministry of Finance has stipulated percentage for earmarking of Scheduled Tribe Component (STC) funds for the Central Ministries / Department as at **Annexure 2**.

As far as allocation of TSP funds by State Governments is concerned, the funds under TSP are to be earmarked from the total plan outlays not less than the population proportion of STs in State as per 2011 Census.

A statement showing earmarking of TSP funds by the Central Government Ministries / Departments vis-à-vis total plan outlay is at **Annexure 3**. A statement showing State wise percentage of ST Population, total plan outlay, TSP Allocation and percentage allocation of TSP as per records available with Ministry of Tribal Affairs is at **Annexure 4**.
