(d): if so, the details thereof along with the name of the Authority which conduct such inspections?

THE MINISTER OF STATE FOR POWER AND NEW & RENEWABLE ENERGY (I/C) (SHRI R.K. SINGH)

(a): The State-wise details of grid connected solar power installed capacity are given in Annexure.

(b): Solar power tariff has come down from Rs. 17.91/unit in 2010 to Rs. 2.44/unit in 2017 for a project at Bhadla, Rajasthan which reflects solar power is becoming cost effective.

(c) and (d): The projects are regularly monitored by the Ministry of New and Renewable Energy and implementing agencies on regular basis through review meetings and field inspections etc.
