Will the Minister of WATER RESOURCES, RIVER DEVELOPMENT AND GANGA

REJUVENATION be pleased to state:

(a) whether the Government has received several requests from various States/UTs especially Madhya

Pradesh, Karnataka and Bihar for grant of approval to the projects/schemes pertaining to various

sectors viz. water resources, irrigation, desiltation, river cleaning, water conservation and

management, dam's capacity utilization etc. during the current plan period;

(b) if so, the details thereof indicating the name of projects/schemes sanctioned and pending for

clearance along with reasons for pendency and time by which these are likely to be cleared, State/UT,

sector-wise;

(c) the details of ongoing projects/ schemes and those pending for implementation/completion

pertaining to each of the said sectors along with funds demanded/released/utilized so far and the

progress made thereunder, State/UT-wise including the efforts made to complete them in stipulated

time;

(d) whether some of the said projects/ schemes have incurred time and cost overruns and if so, the

details thereof, State/ UT-wise and the corrective action taken thereon; and

(e) the details of projects/schemes not working upto their optimal level along with the steps taken for

optimal utilisation of such projects/schemes?

(a) to (e) Central Water Commission (CWC) under this Ministry has received proposals for approval

as Major & Medium Irrigation (MMI)/ Externally Aided projects (EAP) / National Projects / Repair,

Renovation and Restoration (RRR) of water bodies from the State Governments.

The details of EAP received in CWC and their status are given at **Annexure-I**. List of projects

of Madhya Pradesh, Bihar & Karnataka under appraisal in CWC are given at **Annexure-II**.

The details of declared National Projects (sanctioned and pending for clearance) are given at **Annexure-III**. The details of the requests/proposals received with regard to declaring New National Projects and the action taken thereon are given at **Annexure-IV**.

During current plan period, 99 ongoing irrigation projects under Pradhan Mantri Krishi Sinchayi Yojana (PMKSY) in the country have been prioritized in consultation with States, for completion in phases by December, 2019 in mission mode. The Government has approved the funding arrangement for these projects through National Bank for Agricultural and Rural Development (NABARD) for their completion in a time bound manner. Details of the State-wise list of 99 prioritized projects are at **Annexure-V**.

The State-wise details and central assistance released during 2016-17 and 2017-18 under PMKSY- Accelerated Irrigation Benefits Programme (AIBP) and PMKSY-HKKP (Har Khet Ko Pani) are at **Annexure-VI**.

Under Namami Gange Program, 187 projects for various activities such as sewage infrastructure, river front development, ghat & crematoria, ghat cleaning, rural sanitation etc. have been sanctioned, out of which 47 projects have been completed so far. No project has been sanctioned in Karnataka under Namami Gange Programme. The information pertaining to Madhya Pradesh and Bihar under Namami Gange Project are **Annexure-VII**.

THE INFORMATION PERTAINING TO MADHYA PRADESH AND BIHAR UNDER NAMAMI GANGE PROJECT

Madhya Pradesh:

- In Madhya Pradesh, 2 sewerage projects are sanctioned at a total cost of Rs 25.64 Crore in the river Mandakini (at Chitrakoot) and River Beehar (at Reewa)
- Out of these the sewerage project at Chitrakut is completed.
- The sewerage project at Reewa is facing some time over run. However, under Namami Gange programme rigorous monitoring is taken up at project sites to expedite the completion of the project.

Bihar:

- In Bihar, a total of 29 projects sanctioned which are at various stages of implementation at a cost of Rs 4929.19 Cr as per the following details:
 - o Sewerage Infrastructure: 20 sewerage infrastructure projects are taken up which are at various stages of implementation at a cost of Rs 4511.48 Crore.
 - River Front Development/Ghat and Crematoria: 6 projects (including Patna RFD) are under implementation at a cost of Rs 388.83Crore.
 - o River Surface Cleaning: 1 river surface cleaning project in Patna at a cost of Rs 3.96 Cr.
 - o Afforestation: 2 project at cost of Rs 24.92 Crore
- For 3 sewerage infrastructure projects in Begusarai, Munger and Hajipur due to very slow progress of work and tie overrun, the existing contracts are terminated. The projects are under process of retendering with revised estimates.
- One sewerage project at Buxar is under time over run. However, under Namami Gange programme rigorous monitoring is taken up including frequent site visits to the project sites to expedite the completion of the project.
- The projects under Namami Gange are targeted to be completed by 2020.
