1179. SHRI RAJESH PANDEY:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the details of amount spent by the Public Sector Undertakings (PSUs), Government joint ventures and private industry, manufacturing establishments situated in Uttar Pradesh in their territories during the last three years towards regional development under Corporate Social Responsibility (CSR);
- (b) whether some establishments spent the amount under CSR on the purposes other than regional development; and
- (c) if so, the steps taken by the Government to ensure proper utilisation of the CSR funds as per rule?

- (a)&(b): The year 2014-15 was the first year of implementation of Corporate Social Responsibility (CSR) by companies under the Companies Act, 2013 (the Act). CSR expenditure made by the companies is as per activities enlisted in the Schedule VII of the Act. As per filings made by companies in the MCA21 registry for the years 2014-15 and 2015-16 upto 31.03.2017, the total CSR expenditure reported by companies having their registered offices in Uttar Pradesh is Rs. 79.09 crore and Rs. 91.10 crore respectively. Of the reported expenditure, the CSR expenditure made by the companies in state of Uttar Pradesh is at Annexure.
- (c): Ministry has issued clarificatory circular and Frequently Asked Questions (FAQs) dated 18.06.2014 and 12.01.2016 respectively to facilitate effective implementation of CSR. In addition, sensitisation

workshops have been organised by the Offices of Regional Directorate under Ministry of Corporate Affairs to ensure effective compliance of CSR provisions by companies.
