National Missions under NAPCC

1234. SHRI SANKAR PRASAD DATTA:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of various National Missions under the National Action Plan on Climate Change (NAPCC) and the strategy outlined therein to address the challenge of climate change including its present status;
- (b) whether adequate funds have been earmarked for the implementation of the National Missions under the NAPCC:
- (c) if so, the details thereof along with the total outlay earmarked for the 12th Five Year Plan Period and the funds allocated, released and utilized for the purpose during each of the last three years and the current year; and
- (d) the achievements made so far under the NAPCC including reduction of carbon emission in the country?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA)

(a) National Action Plan on Climate Change (NAPCC) comprises of eight Missions namely – National Solar Mission (NSM); National Mission on Enhanced Energy Efficiency (NMEEE); National Mission on Sustainable Habitat (NMSH); National Water Mission (NWM); National Mission for Sustainable Agriculture (NMSA); National Mission for Sustaining the Himalayan Ecosystem (NMSHE); Green India Mission (GIM); and National Mission on Strategic Knowledge for Climate Change (NMSKCC), which address issues relating to mitigation of greenhouse gases and adaptation to combat the adverse impacts of climate change on the environment, forests, habitat, water resources and agriculture. It outlines a number of steps to simultaneously advance India's development and climate change related objectives of adaptation and mitigation.

(b) & (c) Details of year wise funds allocation and expenditure is annexed.

(d) Implementation of activities under national missions and other measures have contributed in reduction of emission intensity of GDP by about 12% between 2005 and 2010, against India's voluntary pledge to reduce the emission intensity of its GDP by 20–25 per cent by 2020, compared with the 2005 level.
