#### INCREASE IN NUMBER OF WORKING DAYS UNDER MGNREGS

#### 1625. SHRI K. PARASURAMAN:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the Union Government has granted permission to some States including Tamil Nadu to increase the number of working days under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS); and
- (b) if so, the details thereof and the details of additional allocation of funds made by the Union Government after increasing the number of working days, State/UT-wise?

# ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a): The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) provides for at least 100 days of wage employment to every rural household whose adult members are willing to do unskilled manual work. Forest Rights Act (FRA) beneficiaries are entitled to 150 days of wage employment per household in a Financial Year.

An additional 50 days of wage employment are provided over and above 100 days in the notified drought affected areas of the States/UTs on recommendation of the Ministry of Agriculture and Farmers Welfare.

(b): The Ministry releases funds to the States based on the basis of agreed to Labour Budget (LB), opening balance, pending liabilities of the previous year for the financial year, if any, and overall performance. State/UTs-wise details of Central fund released under the MGNREGS during the current financial year (as on 19.12.2017) are given at **Annexure**. The fund release for implementation of MGNREGA to States/UTs is a continuous process and Central Government is making funds available keeping in view the demand.
