HOUSING FOR ALL IN RURAL AREAS

1680. COL. SONARAM CHOUDHARY:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether the Government has fixed a target for providing housing to all including rural homeless;
- (b) if so, the details thereof along with the progress in allotment of houses to rural homeless, State-wise;
- (c) whether any relaxation is given for the rural poor living in hilly and desert areas, particularly in Western Rajasthan; and
- (d) if so, the details thereof and if not, the reasons therefor?

ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a) & (b): With the commitment to provide "Housing for All" by 2022, erstwhile rural housing scheme Indira Awaas Yojana (IAY) has been restructured into Pradhan Mantri Awaas Yojana – Gramin (PMAY-G) w.e.f. 1st April, 2016. Under PMAY-G, in initial phase, 1.00 crore houses are proposed to be constructed for the houseless households and households living in zero, one or two room houses with kutcha wall and kutcha roof in rural areas over the period of 3 years from 2016-17 to 2018-19.

A statement indicating houses allotted to the beneficiaries including houseless households under PMAY-G State/UT-wise is given at Annexure-I.

(c) & (d): Under PMAY-G, higher unit assistance of Rs. 1.30 lakh is provided to the beneficiaries of hilly states, difficult areas and IAP districts instead of Rs. 1.20 lakh in plain areas. In addition 95 persondays of unskilled labour wage for hilly states, difficult areas and IAP districts in place of 90 persondays of unskilled labour labour wage for plain areas are available to the PMAY-G beneficiaries.

As per para 5.1.1 of the Framework for Implementation of PMAY-G, there is a provision for classifying an area as difficult area within a State including Rajasthan. No proposal from State Government of Rajasthan has been received in the Ministry of Rural Development in this regard.
