WIND ENERGY PROJECTS

1687. SHRIMATI RITI PATHAK:

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) whether the Solar Energy Corporation of India (SECI) is inviting tenders for identifying developers on the basis of lowest bid for wind energy projects and if so, the details thereof;
- (b) whether lowest bids have been achieved in areas having maximum production and if so, the details thereof; and
- (c) whether the Government has any scheme to ensure that the development of wind energy projects do not get halted in various States including Madhya Pradesh having less power generation capacity and if so, the details thereof?

ANSWER

(a): SECI has been designated as the implementing agency by MNRE for carrying out the bidding for selection of Wind Power Developers on a pan-India basis. Till date, SECI has successfully concluded two rounds of bidding on tariff basis for selection of developers, each having a cumulative capacity of 1000 MW. The details of the bids are given in **Annexure**.

Recently on 30.11.2017, SECI has issued another tender for selection of 2000 MW ISTS-connected Wind Power Projects on tariff based bidding.

(b): The selection of areas where wind power project is to be developed remains in the scope of developers and accordingly they quote the prices. Site of project is decided by the developer based on land availability, wind potential, power evacuation availability etc.

(c): Government of India has framed policies to encourage development of Renewable energy including wind energy in all States. The State Governments are free to exploit their States potential.
