#### ARREARS OF WAGES TO BE PAID UNDER MGNREGS

## 1783. PROF. K.V. THOMAS: SHRI GAURAV GOGOI:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether there is a delay in release of funds by the Government to one or more State under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) for the years 2015-16, 2016- 17 and the current financial year and if so, the details thereof and the reasons therefor, State/UT-wise;
- (b) the details of arrears of wages to be paid to them along with the time by which the said arrears will be paid, State/ UT-wise;
- (c) if not, the details of funds allocated during the said period, State/UT-wise; and
- (d) the details of compensation paid/ to be paid in lieu of the delay in release of funds, State/ UT-wise?

## ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

- (a) to (c): The Ministry releases funds to the States based on the basis of agreed to Labour Budget (LB), opening balance, pending liabilities of the previous year for the financial year, if any, and overall performance. The fund release for implementation of MGNREGA to States/UTs is a continuous process and Central Government is making funds available keeping in view the demand. The Ministry has released Rs. 46409.15 crore to States/ UTs for liquidating the pending liability of wage component and for running the programme during FY 2017-18. States/UTs-wise Central fund released under MGNREGS during the last two years and current year (as on 19.12.2017) are given at **Annexure I**.
- (d): As per the provisions under Para 29 (1) (a), (b), (d) of Schedule-II of the MGNREGA, the compensation for delay in payment of wages is paid to the workers. Since 3rd January, 2014, a sum of Rs. 75.90 crore has been paid as compensation. The State/UT- wise details of compensation paid is given at **Annexure II.**
