#### **VANISHING COMPANIES**

### **QUESTION**

### 1951. SHRI JANARDAN SINGH SIGRIWAL:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the details of number of companies identified as companies which have vanished in the country including Bihar, State-wise;
- (b) whether any committee has been constituted to inquire into the issue related to the said companies and monitor the progress of the action taken against them;
- (c) if so, the number of such companies and their promoters against whom action has been taken so far:
- (d) the details of steps taken by the Government to find out other companies declared as vanished; and
- (e) the measures taken/proposed to be taken by the Government to check such incidents?

#### **ANSWER**

## MINISTER OF STATE FOR LAW AND JUSTICE (SHRI P. P. CHAUDHARY) AND CORPORATE AFFAIRS

(a) to (e) The Government of India has set up a Coordination and Monitoring Committee (CMC), which is a joint mechanism of Ministry of Corporate Affairs (MCA) and the Securities and Exchange Board of India (SEBI), for identifying Vanishing Companies. From the Initial Public Offers (IPOs) which came to be issued during the period 1992-2001, a total number of 238 companies were identified as "Vanishing Companies" by the CMC. Out of these, 161 companies have since been deleted from the list, as they have subsequently been traced. Presently, there are only 77 Vanishing

Companies. The Regional Task Forces (RTFs), with representation from MCA, SEBI and RBI oversee the action taken and their minutes are considered by the CMC.

A Statement, indicating the names of the Vanishing Companies, their issue size, listed under the corresponding jurisdictional Registrar of Companies, as provided by SEBI is at <u>Annexure – I</u>.

Based on the inputs from field offices, the following steps have been taken:

- (1) First Information Reports (FIRs) have been lodged against the 77 vanishing companies and their Directors.
- (2) Prosecutions have been filed against these companies and their Promoters/Directors under section 162 and 220 of the Companies Act, 1956 for non-filing of Statutory Returns and under section 62/63, 68 and 628 of the Companies Act, 1956 for mis-statement in Prospectus/fraudulently inducing persons to invest money/false statements made in the offer documents etc.

No fresh cases involving "Vanishing Companies" have been identified by the CMC.

A number of steps have been taken by the Government to save investors from frauds including frauds by vanishing companies. Some specific measures are:

- (i) In 2006, the Ministry amended the Companies Act, 1956 by inserting Sections 266A to 266G which makes it mandatory for every existing or prospective directors to obtain a "Director Identification Number" (DIN), after submitting verification documents. This has been continued under the Companies Act, 2013.
- (ii) In case of incorporation of a new company or change of address of an existing company, the Ministry has made it mandatory for the professionals to verify details of the company.

(iii) The Registrar of Companies scrutinize the Balance Sheet and other records of the company who raise money through public issue and monitor the utilization of such funds.
