#### Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) whether the Programme Implementation Plan (PIP) process under the National Health Mission (NHM) entails mandatory training and use of specific software and if so, the details thereof;

(b) whether the Government has sanctioned funds to the States for PIP training and software use; and

(c) if so, the details thereof along with the steps taken/being taken by the Government to monitor the use of the said software?

## ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI ASHWINI KUMAR CHOUBEY)

(a) to (c): At present, Programme Implementation Plan (PIP) process under the National Health Mission (NHM) neither entails mandatory training and use of specific software nor monitoring the use of any PIP software.

However, under NHM support is provided to States/ UTs for preparation of Health Action Plan which can be utilised for PIP preparation, including training therefor. The details of funds provided under NHM for Health Action Plan for the FY 2017-18 are at Annexure.
