SCIENTIFIC RECOGNITION TO TRADITIONAL SYSTEMS

211. DR. SWAMI SAKSHIJI MAHARAJ:

Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) whether the Government proposes to establish more Ayurvedic Treatment and Research Centres to accord scientific recognition to the traditional systems of medicine;
- (b) if so, the details thereof State/UTwise including Uttar Pradesh;
- (c) the measures being adopted by the Government to set formal procedure/ protocol to strengthen the standardisation and certification process of the aforesaid traditional systems of medicine in the country; and
- (d) the details of system in place for scientific and statutory recognition and trial testing of the quality of such traditional medicine in the absence of necessary formal protocol in the country?

ANSWER THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

- (a) & (b): There are five Research Councils at present under the aegis of Ministry of AYUSH. One of them, Central Council for Research in Ayurvedic Sciences (CCRAS) carries out their treatment and research activities through 30 peripheral Units/ Institutes (The State/ UT-wise details are given at Annexure). However, presently there is no proposal to establish more Ayurvedic Treatment and Research Centres.
- (c): Pharmacopoeial Laboratory of Indian Medicine, Ghaziabad under Ministry of AYUSH is a Standards setting cum Drugs Testing Laboratory at National Level for Indian Medicines which include drugs of Ayurveda, Unani and Siddha systems.
- (d): Regional Research Institute of Unani Medicine, Chennai is approved as Drug Testing Laboratory by the State Drug Licensing Authority of Tamil Nadu for testing of quality of Ayurveda, Siddha and Unani Medicines taking into consideration pharmacopoeial standard.
