FUNDS ALLOCATED FOR WELFARE OF MINORITIES

2641. SHRI BADRUDDIN AJMAL:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether there are various States including Assam where funds allocated for the welfare of minorities are not utilized properly;
- (b) if so, the details thereof and reasons therefor;
- (c)whether any steps have been taken by the Government about better cooperation between State and Central Government for proper and timely utilization of the funds earmarked for the development of minorities;
- (d) if so, the details thereof; and
- (e) if not, the reasons therefor?

ANSWER

MINISTER OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

(a) to (e). The Ministry is implementing Multi-sectoral Development Programme(MsDP), a Centrally Sponsored Scheme, in 710 Minority Concentration Blocks, 66 Minority Concentration Towns and 15 Clusters of Villages in the country. The State/UTs including Assam formulate and implement projects under the scheme from funds sanctioned and released by Ministry under MsDP. Timely utilization of the funds by the State/UTs are affected in some States/UTs in respect of some projects on account of non-availability of land, delay in release of funds by the States to implementing agencies. To expedite the utilization of funds by States, the Ministry has been conducting regular review meetings with the States governments/UT administration and field visits. The details is at Annexure-I.
