- # Raipur-Jharsuguda New Line Project was included in Budget 2013-14, subject to obtaining requisite approvals. However, NITI Aayog has not approved the project.
- ## Jeypore-Malkangiri (130 km) New line project was included in Budget 2016-17 subject to requisite clearance by the Govt.(NITI Aayog/CCEA). Expanded Board for Railways has approved the project.
- ### Extension of Naupada-Gunupur New Line upto Theruvali (79 Km) has been included in Budget 2017-18 subject to clearance by the Govt.(NITI Aayog/CCEA).

Completion of Railway projects depends upon several factors such as land acquisition, forestry clearances, shifting of utilities, No Objection Certificate from National Highway Authority of India(NHAI), Irrigation department and Archaeological Survey of India, etc. Since most of these factors are beyond the control of Ministry of Railways, no time-frame has been fixed for completion of these projects.

Besides these, land acquisition problems due to frequent agitation by the land-losers for higher compensation, protests by the land-losers for jobs in lieu of their land acquired, shifting of powers lines, removal of encroachments, delay in forestry clearances are the major impediments/obstacles that decelerate the implementation of projects in Odisha State. Regular coordination meetings with State Government authorities by the Railways at Railway level and also at Ministry level are held to sort out these problems.
