(a) whether the private companies and Public Sector Undertakings (PSUs) in Tamil Nadu have allocated and spent funds under Corporate Social Responsibility (CSR) towards community infrastructure development programmes;

(b) if so, the details thereof;

(c) whether the private companies and PSUs in the areas in and around Perambalur District of Tamil Nadu have also spent their CSR funds for the said purpose as per the Companies Act, 2013 containing the CSR provision under Section 135 Schedule VII of the Act; and

(d) if not, the reasons therefor and the steps taken by the Government in this regard?

(a) & (b): Corporate Social Responsibility (CSR) expenditure made by the companies is as per activities enlisted in the Schedule VII of the Companies Act, 2013. The total expenditure on CSR reported by companies having registered offices in Tamil Nadu for the year 2015-16, as per filings made by companies in the MCA21 registry till 31.03.2017, is Rs. 671.06 crore. Of the reported expenditure, the CSR expenditure made by the companies in state of Tamil Nadu is at Annexure.

(c) & (d): CSR expenditure of companies in and around a district is not maintained by the Ministry.
