NEW DRUGS

3206. SHRIMATI POONAMBEN MAADAM:

Will the Minister of AYURVEDA, YOGA AND NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (AYUSH) be pleased to state:

- (a) the details of new drugs developed and new medicines introduced in AYUSH system of medicines along with research works undertaken in this regard during the last three years and the current year;
- (b) whether the Government has taken note of slow progress in development of new drugs in AYUSH stream in view of enforcement of clinical trial method system as followed by modern medicine and the lack of institutional mechanism for AYUSH; and
- (c) if so, the details thereof along with the reaction of the Government thereto?

ANSWER

THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY (SHRI SHRIPAD YESSO NAIK)

- (a): Four among the Central Research Councils functioning under the Ministry of AYUSH, namely Central Council for Research in Ayurvedic Sciences (CCRAS), Central Council for Research in Unani Medicine (CCRUM), Central Council for Research in Siddha (CCRS) and Central Council for Research in Homoeopathy (CCRH) are involved in research activities, including development of new drugs. The details of the new drugs developed/being developed during last three years and current year by these Councils are at **Annex**.
- (b) & (c): The Research Councils under Ministry of AYUSH are actively involved in the scientific process of drug development adopting prevalent guidelines. The process involves standardization of raw drug followed by drug proving, clinical verification and clinical trial. The entire process takes considerable time in completion.
