However, under Loan 3265- Orissa Integrated Irrigated Agriculture and Water Management Investment Program, the expected outcome of the investment in modernization and management of irrigation system and associated infrastructure, is to increase productivity of agriculture in the Mahanadi delta, Brahmani and Baitrani river basins in Odisha.
