Status of Accessible India Campaign

493. SHRIMATI APARUPA PODDAR

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a) the details of physical facilities created under the Accessible India Campaign since 2015, State-wise;
- (b) whether all major Government buildings have been made disabled friendly as mandated under the Scheme and if so, the details of the infrastructure created since 2015; and
- (c) if not, the reasons therefor?

**ANSWER

(a) to (c): Under Accessible India Campaign (AIC), Department of Empowerment of Persons with Disabilities (DEPwD) has been mandated for making 1662 citizen centric Buildings of States/UTs in identified 50 cities. The State-wise number of Buildings being made Accessible under the (AIC) since 2015 by the Department of Empowerment of Persons with Disabilities (DEPwD) is at Annexure-I. The progress is as below:-

- Accessibility audit of 1662 buildings identified by State Governments is completed by Access Auditors and audit reports issued to state governments.
- Retrofitting work in 591 buildings has commenced.
- For the Central Government Buildings maintained by CPWD; they have reported 99 buildings have been made accessible in different cities of the country as per Annexure-II.
