ALCOHOLISM AND DRUG ABUSE

544. SHRI SANKAR PRASAD DATTA: SHRI JAGDAMBIKA PAL:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether cases of alcoholism and drug abuse, especially amongst the youths, have increased across the country;
- (b) if so, the estimated number of alcohol and drug abusers reported in the country, State-wise;
- (c) whether incidents of suicides related to alcohol/drug abuse have also been reported and if so, the details thereof during each of the last three years and the current year, State-wise;
- (d) the action plan/scheme being implemented by the Government for prevention of alcoholism and drug abuse including suicides related to such abuse;
- (e) whether the Government has provided financial assistance to rural and urban local bodies to prevent alcoholism and drug abuse in their areas;
- (f) if so, the details of the financial assistance provided to such bodies including NGOs during each of the last three years and the current year, State/UT-wise and NGO-wise; and
- (g) whether the Government has any proposal to revise the said scheme/ formulate a rehabilitation scheme to curb suicides related to alcohol/drug abuse and if so, the details thereof?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI VIJAY SAMPLA)

(a) & (b): The Ministry of Health and Family Welfare has informed that as per the National Family Health Survey - 4 (2015-16), 29.2% men and 1.2% women consume alcohol, whereas as per National Family Health Survey 3 - (2005-06), 31.9% men and 2.2% women were consuming alcohol.

However, the last National Survey on the extent, pattern and trend of drug abuse was sponsored by Ministry of Social Justice and Empowerment and conducted by the United Nations Office on Drugs and Crime in the year 2000-01. The report was published in 2004. The Survey estimated that about 7.32 Core persons in India were users of alcohol and drugs. Of these 87 lakh Cannabis, 20 lakh used opiates and 6.25 Crore were users of Alcohol. The survey covered 40,697 individuals. Only males within the age group of 12-60 years were part of the Survey. The Survey did not provide state level data.

This Ministry has in the month of August, 2016, assigned the work of conducting the National Survey on Extent and Pattern of Substance Use in India to National Drug Dependence Treatment Centre (NDDTC), AIIMS, New Delhi. The survey will provide national and state-level estimates of proportion and

absolute number of people who use various substances and people who are suffering from substance use disorders.

- (c): As informed by the National Crime Record Bureau, a total of 3647 persons in 2014, 3670 in 2015 and 5200 in 2016 have committed suicide due to drug abuse/alcoholic addiction. State/UT-wise data of number of suicides due to Drug Abuse/Alcoholic Addiction during 2014-2016 is at Annexure –I.
- (d) to (g): The Ministry of Social Justice & Empowerment implements the "Central Sector Scheme of Prevention of Alcoholism and Substance (Drugs) Abuse" under which financial assistance is provided to Non-Governmental Organizations (NGOs), Panchayati Raj Institutions, Urban Local Bodies etc. for, inter-alia, running and maintenance of Integrated Rehabilitation Centre for Addicts. The Cost norms of the Scheme have been revised w.e.f. 01.01.2015. State/UT-wise number of projects assisted and amount released during the last three years and the current year is at <u>Annexure II.</u>

Ministry of Health & Family Welfare (MHFW) have informed that they through Drug De-addiction Programme (DDAP) also provide grants to Central Government Hospitals viz. AIIMS, New Delhi, PGIMER, Chandigarh; and NIMHANS, Bengaluru for treatment of drug addicts including alcohol addicts. NDDTC, AIIMS is functioning as the National/Nodal centre and also coordinating another major component of the DDAP, the "Drug Treatment Clinics (DTCs) Scheme" through which fund is being provided to Government Hospitals for establishment/running of Drug Treatment Clinics. Further, the MHFW through Drug De-addiction Programme provides grants to some Central/States Government Institutions/Hospital for post abuse treatment of drug addicts.
