Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:-

- (a)Whether the Government announced the Disability Awards every year in the country;
- (b) if so, the details of category of disability awards given for the last three years;
- (c) the details of Best Individual and Best Institution for disability service for the said period; and
- (d) whether any special funds has been provided for the service on disability to Best Individual and Best Institution awarded and if so, the details thereof?

ANSWER MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SHRI KRISHAN PAL GURJAR)

- (a) & (b): Yes, Sir. Government confers National Awards under its Scheme called 'National Award for the Empowerment of Persons with Disabilities' on 3rd of December every year on the occasion of International Day for the Persons with Disabilities. Details of categories of the National Awards for the last three years are at **Annexure I.**
- (c): Details of the awards for Best Individual and Best Institution categories working for the cause of Persons with Disabilities for last three years are at **Annexure II**.
- (d): While there is no special fund for the purpose, cash amount of Rs. one lakh is given to every awardee in the Best Individual category and Rs. two lakh is given to every awardee in the Best Institution category.
