Will the Minister of FINANCE be pleased to state:

(a) whether National Bank for Agriculture and Rural Development (NABARD) has allocated the funds for the construction and expansion of cold storages and other developmental works under subsidy scheme and if so, the details thereof, State/UTwise including Uttar Pradesh;

(b) the amount of subsidy allocated for the said purpose under this scheme during the last three years along with the funds to be allocated/proposed to be allocated in the year 2017-18, State/ UT-wise;

(c) the details of funds utilised by each of the States along with the funds lying unutilised; and

(d) the steps being taken by the Government to ensure proper utilisation of the funds by the State Governments in this regard?

Answer The Minister of State in the Ministry of Finance (Shri Shiv Pratap Shukla)

(a) to (d): National Bank for Agriculture and Rural Development (NABARD) has informed that construction of cold storages was an eligible item under the Scheme called "Agriculture Marketing and Infrastructure Grading Standardization" (AMIGS), which got subsumed to Agriculture Marketing Infrastructure (AMI) sub-scheme under the Integrated Scheme for Agri Marketing (ISAM) w.e.f, 1 April 2014. As per the scheme guidelines, there is no provision to make state-wise allocation of funds and it is purely demand-driven. The subsidy is back-ended and is released to borrowers through banks. The AMI sub-scheme has been put on hold from 5 August 2014 by GoI for non-SC/ST beneficiaries in states other than North Eastern Region (NER).

The progress in release of subsidy in respect of cold storage (which has been closed w.e.f 01st May 2010), through NABARD, in various States including state of Uttar Pradesh, as on 30 November 2017 (since inception) as reported by NABARD, is attached as per Annexure.
