(i) National Institute of Ayurveda-Jaipur proposes to have collaborative research in Ayurveda in collaboration with Indian Institute of Technology(IIT)-Bombay for use of Nano Technology in Drug Research in Ayurveda and for Animal Experiments including Microbiology, Histopathology, Acute Toxicity Studies and Publication of Research outcomes in their Journal and also exchange of Faculties and Students with Datta Meghe Institute of Medical Sciences(Deemed to be University)-Wardha(Maharashtra).

(ii) All India Institute of Ayurveda-New Delhi imparts consultancy services of Unani, Homoeopathy and Siddha specialities under one roof in form of ' Integrated AYUSH Clinic'; a Memorandum of Understanding(MOU) has been signed with National Institute for Cancer Prevention and Research(NICPR) under ICMR- Noida and conducting screening and spreading awareness for Breast and Cervical cancer; an MOU with National Cancer Institute, AIIMS for research in cancer prevention & treatment; and MOU with ACRI and Central Council for Research in Ayurveda Sciences.

(iii) A MOU between National Institute for Cancer Prevention and Research(NICPR) and All India Institute of Ayurveda(AIIA) was signed on 19th October, 2016 for setting up a Centre of Integrative Oncology at NICPR-Noida for collaboration in the areas of cancer prevention, research and care. The MOU would pave the way to carry forward the ongoing bilateral dialogue and facilities collaboration with National Cancer Institute in the United States. Inauguration of Centre took place on 3rd February, 2017.
