STATUS OF SOLAR PARKS & ULTRA MEGA SOLAR POWER PROJECTS 944. SHRI ANURAG SINGH THAKUR:

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

(a): the status of the Solar Parks and Ultra Mega Solar Power projects in the country, Statewise;

(b): whether the capacity of these projects increased from 20,000 MW to 40,000 MW and if so, the details thereof;

(c): the estimated electricity producing capacity per year once the projects are operational; and

(d): the criteria for selection of States and Union Territories for the setting up of these projects?

ANSWER

THE MINISTER OF STATE FOR POWER AND NEW & RENEWABLE ENERGY (I/C) (SHRI R.K. SINGH)

(a): The state-wise status of Solar Parks in the country is given in the Annexure.

(b): The capacity of the Solar Park Scheme was enhanced from 20,000 MW to 40,000 MW on 21.03.2017 with objective of setting up at least 50 solar parks by 2019-20.

(c): Once the capacity of 40,000 MW of solar projects is commissioned inside the solar parks, the electricity of around 66,400 million units per annum would be generated.

(d): All the States and Union Territories are eligible under the scheme. All States/UTs have been requested to submit the proposals for setting up of solar parks indicating availability of land in accordance with scheme guidelines. The solar parks are allocated to various States/UTs based on proposals received from them.
