(a) whether any schemes/proposals for water supply have been submitted to the Government by various States including Karnataka during the last three years;

(b) if so, the details thereof; and

(c) the action taken/to be taken by the Government thereon?

(a) to (c) As per the information received from Ministry of Drinking Water and Sanitation (MoDW&S), the State-wise details of the rural drinking water supply project proposals submitted to Department of Economic Affairs, Ministry of Finance through MoDW&S during the last 3 years are at **Annexure-I**. In respect of drinking water supply to the border out posts in Border States, six States have submitted drinking water project / proposals in respect of Border out Posts to be funded by Department of Border Management, Ministry of Home Affairs. State wise details are at **Annexure-II**. No project proposal has been submitted by the Government of Karnataka to MoDW&S in the last 3 years. MoDW&S examines the proposals submitted by the State Governments and make suitable recommendations to Department of Economic Affairs for further processing.

Further, the Ministry of Housing and Urban Affairs (MoH&UA) has launched Atal Mission for Rejuvenation and Urban Transformation (AMRUT) on 25.06.2015 to strengthen the urban infrastructure in the 500 Mission Cities. The Mission has first focus on universal coverage of water supply in the Mission cities. Under AMRUT, the Central Government approves the State Annual Action Plans (SAAPs) of States/UTs and releases the funds. The individual projects are prepared, appraised and implemented by the concerned State Governments/UTs in accordance with the Mission Guidelines. The details of water supply proposals submitted by various States including Karnataka during last three years are at **Annexure-III**. The MoH&UA has approved all the three SAAPs submitted by the Karnataka State and released 1st instalment of the approved SAAPs, which is given as under:
